Uyu mushinga w'ingenzi usaba uruhushya rwawe kugirango umukozi wacu acukure akanogo gato ku mutungo wawe akenshi ni sentimetero eshanu uvuye kuri konteri y'amazi ndetse n'akandi muri ubwo buryo. Bazakoresha uburyo butagaragara cyane, bwitwa gucukura ukoresheje akuma kabugenewe, kugirango bamenye amatiyo by'amazi yawe. Izeza ko bazongera bagatunganya aho bacukuye bakahasubiza uko hari hameze.

Igiherekeza iyi baruwa ni Uburenganzira bwo kwinjira (ROE) nyir'umutungo asinya kugirango atange uburenganzira ku mutungo yawe. Iyi fishi ishobora gusinywa no kutugarukira ukoresheje ibahasha isubiza yashyizwemo.
