



Itangazo ryo kumenyekanisha umuyoboro w'amazi urimo lead ukeneye gusimbuzwa

Mukiriya mwiza:

Ishami ry'Amazi mu muji wa Dayton ni wo muyoboro rusange w'amazi (PWS) ushinze gutanga amazi yo kunywa kuri iki gice. Urimo kwakira iri tangazo kuko inyandiko zigaragaza ko iyi nzu cyangwa iyi nyubako ifite umuyoboro w'amazi wa garuvanize ukeneye gusimbuzwa (GRR).

Umurongo w'amazi ni umuyoboro uhuza umuyoboro mukuru w'amazi n'inyubako. Amazi yo kunywa muri Dayton nta kinyabutabire cya lead kirimo; ariko abantu bafite imiyoboro y'amazi irimo lead ku mitungo yabo bashobora guhura n'ingaruka zo guhura na yo.

Ibi bishatse kuvuga iki?

Hashingiwe ku itegeko ryo Kunywa Amazi Meza, Ikigo cya Leta Zunze Ubumwe za Amerika gishinze kurengera ibidukikije (EPA) kidusaba kumenyeshya abakoresha amazi bahabwa amazi binyuze mu muyoboro wa serivisi wa GRR.

Umuyoboro wa serivisi wa GRR ni aho umuyoboro wa serivisi wakoze mu cyuma cya garuvanize uri cyangwa wigeze kuba, igihe icyo ari cyo cyose, uri nyuma y'umuyoboro wa serivisi wakoze muri lead, cyangwa ubu uri inyuma y'umuyoboro wa serivisi aho bitazwi niba harimo lead. Iyo gahunda y'amazi rusange (PWS) idashoboye kwerekana ko umuyoboro ukoze muri garuvanize utigeze na rimwe uba inyuma y'umuyoboro wa lead, igomba gufata umwanzuro ko habayeho umuyoboro wa lead uri hejuru.

I Miyoboro ya garuvanize ishobora gufata lead irekurwa n'umiyoboro ya lead iri hejuru yayo. Uko igihe kigenda gihita, utuntu duto twa lead dushobora kwinjira mu mazi yo kunywa, bigatuma urwego rwa lead mu mazi rwiyongera.

Ni izihe ngaruka Lead igira ku buzima?

Nta rwego rwizewe rw'umuyoboro wa lead ruba mu mazi yo kunywa. Ukwinjirirwa na lead mu mazi yo kunywa bishobora guteza ingaruka zikomeye ku buzima ku bantu b'ingeri zose, cyane cyane abagore batwite, impinja (zaba izigaburirwa amata y'ifu cyangwa izonka), ndetse n'abana bato. Zimwe mu ngaruka ku buzima ku mpinja n'abana zirimo kugabanuka kw'ubwenge (IQ) n'ubushobozi bwo gutuza. Ukwinjirirwa na lead bishobora no gutera cyangwa kongera ibibazo byo kwiga n'imitwarire mibi. Abana b'abantu bahuye na bandujwe na lead mbere cyangwa mu gihe cyo gutwita bashobora kugira ibyago byinshi byo guhura n'izo ngaruka mbi ku buzima. Ku bantu bakuru, lead yongera ibyago byo kurwara indwara z'umutima, umuvuduko w'amaraso, n'ibibazo by'impiko cyangwa sisitemu y'umyaka. Baza cyangwa uhamagare umukozi w'ubuvuzi ukwitaho kugira ngo ubone ibisobanuro birambuye ku byago ushobora kugira.

Ni iki nakora kugira ngo ngabanye lead igihe igaragaye mu mazi yanjye yo kunywa?

- **Ntushyushye amazi kugira ngo uvanemo lead.** *Gushyushya amazi ntibizagabanya lead.*
- **Fungura robine yawe niba imaze amasaha 6 cyangwa arenga idakoreshe.** Urwego rwa lead rwiyongera uko amazi amara igihe ari mu miyoboro irimo lead. Gukoresha amazi kenshi mu rugo cyangwa mu nyubako bishobora kugabanya urwego rwa lead mu mazi yo kunywa. Iyo amazi adakoreshejwe amasaha 6 cyangwa arenga, mu ngo n'inyubako zifite imiyoboro ya lead cyangwa iri garuvanize ikeneye gusimbuzwa, umuyoboro ukwiye gufungurwa kugeza ubonye impinduka y'ubushyamba, hanyuma ufungure undi munota umwe.
- **Koresha amazi akonje mu guteka, kunywa, no gutegura amata y'impinja.** Ntugateke, unywe, cyangwa utegure amata y'impinja ukoresheje amazi ashushye aya kuri robine yawe y'amazi ashushye. **Lead** ishonga byoroshye mu mazi ashushye. Komeza ukoreshe amazi akonje, hanyuma uyashyuhwe niba bikenewe.
- **Koresha akayungiro k'amazi kemewe na ANSI gakuraho lead.** *Utuyungiro twemewe na ANSI/NSF 53 two gukuraho lead dushobora kuba ingirakamaro mu kugabanya urwego rwa lead mu mazi. Kurikiza amabwiriza y'uwoho akayungiro ku buryo bwo kugakoresha neza, harimo n'igihe cyo gusimbuza akayungiro. Turagusaba gukoresha akayungiro kemewe na ANSI/NSF 53 ko gukuraho lead byibuze amezi atandatu nyuma yo gusimbuza imiyoboro y'amazi.*
- **Sukura kenshi igikoreshe cyawe cy'umwuka.** Mu gihe kirekire, utuntu dufite lead dushobora kwiyongera ku rukuta rw'imbere rw'ikirahure cy'igikoreshe cy'umwuka. Gukora isuku kenshi ku gikoreshe cy'umwuka bizafasha gukuraho iyi lead.

Ni iki nakora ngo ngabanye Lead niba nyibonye mu Mazi yanjye yo Kunywa? (Byakomeje)

- **Ku bagore batwite, impinja, n'abana bato.** Bamwe mu bantu, nk'abagore batwite, impinja, n'abana bato, bashobora kugira ibyago byinshi byo guhura n'ingaruka mbi za lead. Aba bantu bashobora gufata ingamba z'inyongera niba urugo rwabo rufite imiyoboro ya lead cyangwa iri garuvanize ikeneye gusimburwa. Izo ngamba zinyongera zishobora kuba harimo gupima amazi yo kunywa kugira ngo harebwe urwego rwa lead, gukoresha indi soko y'amazi (nko gukoresha amazi afunze mu macupa) cyangwa gukoresha akayungiro kemewe na ANSI/NSF 53 gakuraho lead.
- **Simbuza ibikoresho by'amazi byafashwe na lead.** Ibikoresho byinshi by'amazi bya kera, nk'amarobine, **itiyo**, n'ibindi bikoresho byo mu miyoboro, bishobora kugira lead. Menya niba ibikoresho by'amazi by'inyubako yawe bifite lead kandi ubisimbuzwe igihe bibaye ngombwa.
- **Ushobora gupimisha umwana wawe lead mu maraso.** Ishami rishinzwe ubuzima mu ntara utuyemo ushobora kurigana rikagufasha birushijeho.

Ushobora gupimisha niba amazi yawe arimo lead.

Niba ibipimo by'amazi yawe birengeje urwego rwemewe rwa **lead**, Umuji wa Dayton uzaguhaha utuyungiro tw'akazi n'udushya two gusimbuza ku buntu kugira ngo uyungure amazi yawe.

Ni iki wakora cyerekeye Umuyoboro wa GRR?

Igice byihariye cy'umuyoboro w'amazi gifite nyiracyo kandi gisimburwa ku giciro cya nyir'umutungo. Umuji wa Dayton uragirwa inama cyane yo guhamagara umukozi ukora amazi wemewe ngo akore kuri uwo muyoboro w'amazi.
